Florida Parrot Rescue, Inc. agrees to provide for placement of, and the Adopter agrees to adopt, the Bird described above, according to the terms and conditions set forth herein:

The Bird being adopted has been surrendered, abandoned, or in some way displaced. He/She may have been abused or neglected. There may be limited, if any, information available regarding the Bird's previous environment. All available information and medical records have been provided to the Adopter. Florida Parrot Rescue, Inc. does not guarantee, nor is it responsible for the temperament or health of this Bird, other than as is separately set forth in the Contract. There will be an adjustment period. Remember to be patient, consistent, and understanding.

- 1) Adopter agrees that this Bird will NOT be used for breeding at any time under any circumstances.
- 2) Adopter agrees to accept this Bird to live in the Adopter's home. Adopter agrees to provide this Bird with proper food, water, veterinary care, and loving attention. Adopter agrees to keep this Bird in a large cage or aviary and to provide the Bird with adequate toys and perches. Adopter agrees to provide the Bird with appropriate exercise for his/her species. Adopter agrees to obtain pertinent information regarding the proper care of this Bird and to seek assistance from appropriate resources, including Florida Parrot Rescue, Inc., as needed.
- 3) Adopter agrees to have this Bird checked by a licensed veterinarian specializing in avian medicine, within ten (10) calendar days of adoption. If the veterinarian finds any life-threatening condition within ten (10) calendar days of adoption that was present at the time of adoption, Adopter may return this Bird to Florida Parrot Rescue, Inc. for a refund of the adoption fee and any veterinary expenses that were paid to Florida Parrot Rescue, Inc. at the time of adoption, provided that written documentation is furnished

by an avian veterinarian, and is provided that this Bird is returned to Florida Parrot Rescue, Inc. no later than thirty (30) calendar days after adoption. Adopter acknowledges and agrees that Florida Parrot Rescue INC. will not refund to Adopter and veterinary expenses paid to a veterinarian at any time after the date of the adoption of this Bird.

4) Adopter understands that avian medicine is a relatively new discipline, and that it is possible for a bird to be a carrier of, or infected with, a disease that is undetectable using the current tests and tools available to avian veterinarians. Florida Parrot Rescue, Inc. is not responsible for any incidence of disease in the adopted bird detected or diagnosed more than ten (10) calendar days after adoption. Florida Parrot Rescue, Inc. is not responsible for any incidence of disease in other birds, other animals, or humans in the Adopter's home detected or diagnosed any time after the adoption of a bird from Florida Parrot Rescue, Inc. The adopter further understands that all parrots coming into Florida Parrot Rescue are vetted to include a physical, gram stain and throat swab. Specific disease testing and/or blood work is not completed unless recommended by the Florida Parrot Rescue vet. The Adopter further agrees that this bird must see a veterinarian annually for a physical and at minimum a fecal gram stain and/or any other treatment recommended by the chosen veterinarian .

5) Adopter understands that it is his/her responsibility to quarantine any adopted bird brought into his/her home for not less than ninety (90) calendar days, or as is recommended by an avian veterinarian treating the adopted bird. This quarantine period is for the protection of the adopted bird as well as the protection of any other birds in the Adopter's home. Adopter understands, however, that no period of quarantine can insure against the spread of any disease. The adopter also understands that they are responsible for disease testing any bird they have adopted.

6) Adopter shall allow Florida Parrot Rescue, Inc. the right to examine and make inquiry about this bird at any reasonable time. Adopter understands that Adopter shall return this bird to Florida Parrot Rescue, Inc. if at any time subsequent to the adoption, Florida Parrot Rescue, Inc. determines this bird is not receiving proper care. With no refund of the adoption fee required.

7) Adopter agrees that if at any time Adopter is unable to keep this bird at any time for any reason, the Adopter shall immediately contact Florida Parrot Rescue Inc. for its sole determination as to the disposition of this bird and to relinquish the bird back to Florida Parrot Rescue Inc. Adoption fees are not refundable under any circumstances, except as provided in paragraph 3 of this Adoption Contract. The adopter further agrees that this Bird must remain in his/her personal home and under his/her personal care. The adopter also agrees that they will not sell, give away or otherwise rehome this bird to any other person (s) or facility.

8) If the expense of medical care exceeds the Adopter's ability to provide appropriate and necessary treatment, Adopter agrees to contact Florida Parrot Rescue, Inc. immediately for a determination of available assistance from Florida Parrot Rescue, Inc.

9) Failure to comply with any of the conditions set forth in this Contract constitutes breach of this Contract for which the Adopter agrees to pay liquidated damages of One Thousand Dollars (\$1,000.00) and/or return the bird to Florida Parrot Rescue, Inc. Adopter agrees to pay reasonable attorney's fees and court costs in the event this matter is referred to an attorney for legal action. Adopter agrees and understands that any legal action undertaken between the signed parties below shall be filed in the Florida county of incorporation of Florida Parrot Rescue, Inc.

10.-) Adopter agrees that if his/her contact information changes, he/she must contact Florida Parrot Rescue Inc. with change of address and/or phone number.

11) Adopter promises to comply with the laws and ordinances enforced in the jurisdiction in which the Adopter resides.
